

Casnovia Township Regular Board Meeting for June 12, 2023, at 7:00 PM

Regular Board Meeting called to order with Pledge of Allegiance at 7:00 PM by Supervisor Kelli Ashbaugh.

Approval of Agenda made by Willick, supported by Jorgensen; CARRIED.

Motion to approve minutes of May 8th, 2023, made by Jorgensen, supported by Willick; CARRIED.

Presentation for security cameras by ROK Systems LLC, Micheal Stickel advanced with updated security quotes including cameras and an entry door lock system at the Fire Department. The board will continue to analyze the direction to be taken.

1. FIRE DEPARTMENT:

Caleb Gort was recognized in his achievements and sworn in as one of the newest members of the Casnovia Fire Department.

Chief Deems presented the Incident Run Log; 26 calls for May 8th – June 12^{th,} 2023 reporting. New radio communication standards were also discussed with possible implementation of personnel responsibility.

Muma presented the treasurer's report. Discussed Choice One updated township personnel, received Senior Allocation funding for 2023, letters regarding delinquent Personal Property tax were mailed, and summer tax bill agreement with KCI was signed.
